3. Within 6 months after the beginning of a fiscal year: Profit-seeking businesses apply for the use of Blue Income Tax Form for filing returns. (exceptions to newly established profit-seeking businesses)
4. Within 1 month before the end of a fiscal year: Newly established businesses apply for the use of Blue Income Tax Form for filing Income Tax Return.
